A. CRC Student Equity Plan (SEP), 2019-2022

Under the purview of this committee we will advise and provide feedback on this 3-year plan. The SEP is required for Student Equity and Achievement funds (formerly three categorical funding programs: SSSP, BSI, and Student Equity). Going forward under the new fund we need new equity goals for the overall population as well as the disproportionately impacted students. In the equity plan the College will need to set goals as well as provide activities to achieve these goals. The SEP Workgroup defined 'activity' and identified students in each area and how to reduce the equity gaps for disproportionately impacted students. Looking at the past Integrated

Student Success Plan, it is specific to programs and would like to shift things in the future making sure that we are general enough to include all areas and projects. March 22 is the first reading at Academic Senate, and will be vetted through the participatory governance process well before deadlines. Plan complete is due June 30, 2019.
