Discussion of GE Themes/ GE PD Institute	Kick-off work on GE themes at CRC's 2019 GE PD Institute went extremely well. Over sixty people attended, 73% faculty. Convergence by participants (working in 7 independent groups brainstorming themes) was striking.
