	Humanities- Is requesting to be aligned to Social and Behavioral Sciences rather than English, Humanities and Language Studies. Humanities is part of Global Studies Program along with International Relations (Political Science). Faculty are often minimally qualified in both Humanities and Philosophy or Humanities and History. Philosophy and Humanities currently share adjunct faculty. Requires change to recommendation. Committee supports this change.		
	Economics- Committee has heard from Department Chair, who supports the current draft alignment. However, program faculty are split on their recommendations. Will consider at 9/26	Rick	9/26/18
